Current projects

I am an external member of the interdisciplinary research group, Homo-Debilis (www.homo-debilis.de), run by Professor Cordule Nolte at Bremen University, Germany. Members of Homo-Debilis are working to discover how people experienced disability in the pre-modern era, and to explore the impact of disability on society as a whole.

My research interests are focused upon relationships between representations of physical and social difference in the 16th- and 17^{th} -century Spanish Hapsburg court and the lived experience of the people portrayed, be they monarchs or the 'fools' and dwarfs who entertained them. I interrogate images within their original contexts for what they can tell us about contemporary attitudes towards the anomalous body.
